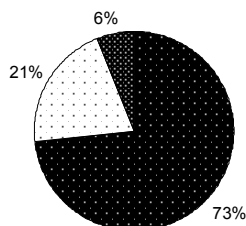
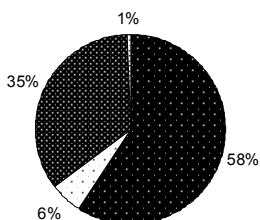

## 2002-2003 Accomplishments and Highlights

### FAMILY SUPPORT PROGRAM

SCAN's Family Support Program continued to grow steadily during the 2002-2003 fiscal year. SCAN provided 24 free support and education groups each week to adults and children who have experienced or are at risk of experiencing abuse and neglect. Through the Family Support Program, SCAN served 352 adults and 230 children through an intensive, family-focused model of service delivery.

SCAN increased the number of groups designed for special needs populations. These groups included two groups for court ordered parents and a group for foster parents. SCAN continued participation in Richmond's Family Drug Treatment Court by establishing a group for parents whose children tested positive for drugs at birth.

The KinCare Group, designed for grandparents and other kin raising children, continued to grow and expand during 2002-2003. The group was honored as the "Best Practices" support group for grandparents and other kin raising children by Generations United (GU) after GU visited 24 sites throughout the US.

We relied on the help of dedicated volunteers to assist with activities in the Children's Groups. In 2002-2003, SCAN volunteers gave over 1,500 hours of their time. They helped children overcome the trauma of child abuse and neglect.

During 2002-2003, SCAN families attended a weekend family retreat. They spent relaxing and fun time together in a nature setting. This was a great experience for families, allowing them to get away from their daily lives and simply enjoy spending time together as a family.

### PUBLIC EDUCATION PROGRAM

SCAN's Public Education Program is designed to create awareness of the problem of child abuse and neglect in the greater Richmond area. During the 2002-2003 fiscal year, SCAN participated in 55 public education events, averaging one event each week, and reached an estimated 6,000 people.

During April 2003 National Child Abuse Prevention Month, SCAN distributed nearly 20,000 blue ribbons to the community. SCAN also distributed nearly 400 posters for Child Abuse Prevention Month to schools, child care centers, churches and social service agencies. Finally in April, SCAN participated in numerous public education and/or media events highlighting the problem of child abuse and neglect in our community.

SCAN partnered with the Junior League of Richmond and provided parenting workshops in Richmond public schools. These workshops were designed to help high risk families reduce their stressors so they could help their children focus on education. Through helping parents reduce stressors, SCAN's goal was to help elementary school children be well-prepared for learning.

SCAN staff taught classes at John Tyler Community College and at Virginia Commonwealth University and spoke at a variety of conferences and meetings, which helped educate the public about the problem of child abuse and neglect in our community.

### CHILD ADVOCACY CENTER

SCAN began working to develop a Child Advocacy Center (CAC) in Richmond. The CAC in Richmond will be the first of its kind locally and will greatly enhance the treatment and investigation of severe physical abuse and sexual abuse cases in our community.
